**COURSE OVERVIEW:** The CISM: Group Crisis Intervention training program presents the core elements of a comprehensive, systematic and multi-component crisis intervention curriculum. This two-day course prepares participants to understand a wide range of crisis intervention services including pre and post incident crisis education, crisis intervention for individuals, demobilisations and crisis management briefings after large scale traumatic incidents, and small group defusings and debriefings. The need for appropriate follow-up services and referrals when necessary is also described. The course prepares individuals to provide these interventions.

**TRAINER: Dr Robyn Robinson AM, PhD.** Robyn is a Clinical Psychologist. She is the Founding and Current President of CISMFA. She has trained approx. 300 CISM and peer support teams in Australia and overseas and been guest lecturer in 11 countries.
